

# IMPORTANT INFORMATION

As a registered club, all guests are required to sign in on arrival. Guests living within a 5km radius of the club will need to be a member or be signed in by any existing member. Guests from outside the 5km radius can sign in directly as a temporary guest. Social membership is available at the venue for \$15. We recommend signing up for membership prior to your event if possible to ensure you have a smooth entry into the club and get to spend as much time as possible enjoying our facilities.

# **BOOKINGS**

Bookings are limited to 10 guests per rink or table. (Multiple areas can be booked for larger groups). A payment is required to confirm any group booking. This can be in the form of a table deposit, a rink payment, or a food and/or drink payment.

All bookings made through our website must be made 3 days in advance. If you have missed this cut off please contact us at <a href="mailto:bookings@bondibowlo.com">bookings@bondibowlo.com</a> and we will endeavour to accommodate your group.

Catering orders must be placed and paid for at least 7 days in advance of your booking date.

We do also accept walk-ins however we cannot guarantee table or bowling rink availability.

# **BAREFOOT BOWLS**

Cost per rink is \$200 for 2 hours. One rink is suitable for up to 10 guests.

You will also be assigned a table next to your bowling rink for the duration of your bowls booking. If you would like to stay for longer an additional table reservation must be made to ensure seating is available for your group.

Bowls bookings are made <u>on the hour</u> and we recommend arriving up to 15 minutes before your assigned bowls time to ensure enjoyment of the full booking period.

# **TABLE RESERVATIONS**

Tables of up to 10 people can be reserved, although multiple tables can be booked. This requires a \$50 deposit per table payable at the time of your booking and redeemable on the day of your function by way of a bar tab. This deposit can also be used as credit towards any pre-ordered catering.

# **BEVERAGES**

Bar tabs can be pre-paid or setup on the day of your function. If you wish to set a bar tab up on the day of your function ensure you bring a physical ID and credit/debit card to be kept behind the bar for the duration of your tab.

We have a vast selection of craft beer (18 taps), wines, spirits, cocktails and non-alcoholic beverages on offer.

Please note: The staff at Bondi Bowling Club reserve the right to refuse service and practice the Responsible Service of Alcohol.

# **CATERING**

When organising your catering please let us know if any of your guests have dietary requirements or allergies so we can assist you with your selection.

All catering must be prepaid at least 7 days prior to your event. Catering is not refundable or transferable if your booking is cancelled within 5 days of your event.

#### **TERMS & CONDITIONS**

- Agreement Bondi Bowling Club Cooperative Limited agree: 'We', 'us' or 'our' means Bondi Bowling Club Cooperative Limited (A.B.N 98 063 043 558) and 'you' or 'your' means the hirer.
- The Agreement comprises these Terms and Conditions and the Schedule. The Agreement cannot be changed unless we agree in writing. These Terms and Conditions override any terms and conditions you may wish to impose.
- The 'premises' means our functions rooms located at 1a Warners Ave, North Bondi, 2026.

#### **CLUB ENTRY**

- All Guests attending an event at the Club are required to comply with the sign in requirements of the Registered Clubs Act 1976 (NSW) or any other State or Federal legislation. Guests are advised to produce photo identification as proof of address upon entering the club.
- Normal dress regulations apply for any function held on the premises. Fancy Dress may be permitted if approval requested at time of booking.

#### **ENTERTAINMENT/DECORATIONS**

- The club reserves the right to monitor the volume of any entertainment and request it be lowered if unreasonably loud and affecting other patrons and/or neighbours.
- Strippers or any other form of adult entertainment are not permitted.
- You may decorate the room/space, however all items are to be attached by blutac only unless otherwise advised
- No confetti, streamers or messy items permitted.

#### **FOOD & BEVERAGES**

- No outside catering is permitted to be brought onto the premises. An exception is made for celebration cakes.
- No outside beverages are permitted to be brought onto the premises.
- Our kitchen will take care in preparing menu items, however some food products may contain allergens that individual guests may be allergic to, and the club will not be responsible for illness that may result.
- If you have made a specific request for beverages the Club does not ordinarily provide and the Club had to order in specifically for your function at your request, any refund of that component will be subject to the supplier accepting the stock for a credit. There will be a \$50 administrative charge by the Club to cover the administration and handling costs.
  - 18TH BIRTHDAY PARTIES ARE NOT PERMITTED AT THE CLUB.

#### 21ST BIRTHDAY PARTIES

- 21st Birthday Parties are required to have security at the customer's expense, for the duration of the function. The security must be organized through the club at least 7 days prior. The number of security guards required will be dependent on the number of guests attending at a cost of \$60 per guard per hour.
- Beverage packages are not permitted for 21st birthday party functions.

#### **CHILDRENS BIRTHDAY PARTIES**

• Any events involving a number of young children will be considered for approval only after consultation with Senior Management. We expect an acceptable ratio of older adults to provide adequate supervision. We remind parents that we are a licenced premises designed to cater for adults and our venue may not be suitable for your child's party. Our bar staff are not babysitters and if at any point children exit the designated area without a responsible adult the party will be shut down, guests will be asked to leave and all monies will be forfeited.

#### **PAYMENT - CONFIRMATION AND FINAL NUMBERS**

- You must pay Bondi Bowling Club
- a) Any one part of your booking's cost to secure your booking.
- b) All catering and other costs relating to your function must be paid for in full at least 7 days prior to your function.
- A penalty for a late change in the numbers may incur. Your payment options are: Cash, EFT, Bank Transfer, Visa or MasterCard. Personal cheques will not be accepted.

#### **INDEMNITIES**

You are liable for and release and indemnify us and our employees and agents against:

- a) loss or loss of use or damage or destruction to the premises and our property;
- b) any claim, demand, loss or cost in respect of personal injury, death or loss of use of or damage or destruction to any other property, caused by your breach of this agreement, your negligence, wilful act or omission, or the negligence, wilful act or omission of your employees, agents or invitees.

#### **INSURANCE**

- You must not do or omit to do, or permit to be done or omit to be done, anything which might affect any insurance policies held by us in respect of the premises.
- If applicable, you must obtain and maintain the following insurance policies for the hire with a reputable insurer approved by us;
- a) public liability insurance for not less than \$20 million for each claim;
- b) workers compensation insurance as required by law; and
- c) loss or damage to your goods, equipment and materials on the premises for their full replacement value.
- If we ask, you must give us evidence of these insurances, including certificates of currency
- You must notify us immediately if you become aware of any circumstances which result, or may result in a claim being made against us in respect of the use of the premises.

#### **TERMINATION**

We may terminate your booking immediately by giving written notice if you commit a serious breach of these terms and conditions. (In our opinion, acting reasonably).

#### WET WEATHER PLAN (OUTDOOR AREAS)

If weather renders the outdoor area unusable on the day, we will relocate you to an indoor area. Please note catering and barefoot bowls payments are not refundable. Payments made for barefoot bowls will be converted into credit to be spent at the club. If you choose to cancel your event due to wet weather you can choose to re-book for another date, in this case all food payments will be forfeited.

#### **OUTSOURCED PLAY EQUIPMENT**

Outsourced play equipment is not permitted.

#### **PARKING**

The club does not have any parking available for customers. Limited street parking is available around the club. We have a loading dock which can be used by event organisers for the set up/pack down of events with prior permission granted.

#### CANCELLATION

In the event of a cancellation, costs will have been incurred in terms of rostered staff and food ordered. The costs of cancellation are as follows and relate directly to the period of notice provided:

- a) One calendar month or more full refund
- b) 14 days to 1 calendar month 50% refund of deposit
- c) Less than 14 days no refund

All cancellations must be in writing and be made by the person who organised the function.

#### **PREMISES**

- We will make the premises available to you on the date(s) and time(s) requested.
- You and your employees, agents and invitees use and occupy the premises at your own risk.
- You must comply with and ensure that your employees, agents and invitees comply with these terms and any rules or directions for the use of the premises advised by us from time to time.
- We reserve the right for us and our employees, agents to have free access to all parts of the premises at all times.
- We do not allow outside play equipment to be brought onto the premises.

#### RESPONSIBLE SERVICE OF ALCOHOL

Bondi Bowling Club practices Responsible Service of Alcohol. If any guests or delegates at a function are showing signs of intoxication or are under the legal drinking age, they will be refused alcoholic beverages. Breaching RSA laws incur fines of up to \$5,500, both to the Club, to any one that is intoxicated and to any person supplying alcohol to an intoxicated or under age individual. In accordance with licensing laws, if a person is deemed intoxicated, they will be directed to leave the premises.

#### **SMOKING**

All indoor areas and most outdoor spaces, including on the greens, are non-smoking and non-vaping. Outdoor smoking areas are easily accessed along the side of the building, guests are allowed to smoke and vape only in these outdoor areas. If guests do smoke or vaping within the Club, except the designated outdoor area, they will be asked to leave the Club as they have breached the tobacco laws.

#### **DAMAGE**

The event organiser is responsible for the behaviour of the guests. Any damage reported will be assessed and payable by the organiser. In some circumstances we may request a \$500 bond be charged.

#### **VENUE HIRE/ ROOM COSTS**

The cost of venue/room hire will be determined on a function-by-function basis. This fee will be based on the following factors; what type of function is being held, what is expected of the club during your function, duration of the event, the amount of people, and day, date & time of your function.

The entire venue may be booked out for a fee. If the full venue is booked out, Bondi Bowling Club reserves the right for full bowling members and life members to still access the club without charge. 'The Nest' is not included in full venue hire.

#### **DECORATIONS**

All decorations must be removed by the client on the conclusion of the function or at a time that has been agreed with the club. Decorations must be approved by the club prior to the event. Clients will be financially liable for any damage sustained to the Club or its property. The cost for repairs or replacement for any damage that occurs will be passed on to the client as will a cleaning fee if this is deemed necessary.

#### **ENTERTAINMENT**

The event organiser can apply for DJs, live acts, and trivia hosts to be approved by the senior management at least 7 days prior to the event. If the client wishes to book entertainment themselves then the details of the act will need to be provided to the event organiser prior to the booking for approval. Use of club equipment; audio/visual system, microphone etc. must be preapproved. All entertainment must comply with the Club's Noise Mitigation Policy, any breach may see entertainment ceased immediately.

A stage hire fee of \$250 will apply to any booking wishing to utilise the stage before, during or after their event.

#### **NOISE MITIGATION**

All outdoor areas will close at 9pm. Patrons will then be welcome to continue their evenings inside the club house. For further information regarding noise restrictions please consult our noise mitigation policy which can be provided upon request.

#### **BOWLS CONDITIONS OF PLAY**

No shoes can be worn on the green but shoes must be worn at all times inside the venue. No children under the age of 16 may play bowls or step onto the green, even with the supervision of an adult. No drinks of any kind can be brought onto the green. Bowlers must respect the club's facilities by bowling with care in the style demonstrated by our resident bowler at the start of their bowls session.

#### DOGS

Dogs are only allowed in the outside areas of the club. Dogs are not permitted on the greens at any time and repeated failure to comply with this stipulation may result in your being asked to leave the venue.

#### **CHILDREN AND MINORS**

As a Registered Club, the regulations and laws of the Office of Liquor Gaming and Racing (OLGR) and the Registered Clubs Act are applicable to all parents and guardians of children and minors while at the Bondi Bowling Club. A Minor is defined by law as any person under the age of 18 years of age. This includes babies and infants.

Minors must be under adult supervision at all times. Minors are not permitted in the bar area at any time and not within 1.5 metres of the bar in the dining area. Minors must be accompanied by an adult when using the bathrooms. Minors under the age of 16 are not permitted on our greens at any time. Minors must behave with decorum while in the venue so as to not disturb our other guests and should remain under the supervision of their parents/ guardians at all times.
